Shawn Sweere reported that balance at the end of 2021 was \$323,139.26

REPORTS:

Hospital Report: presented by Richard Richter. There is new leadership at Perham Health; Brett Glawe, Clinic Dept. Chair, Tracey Bovkoon, Director of Pharmacy, Tony Ellingson, Director of Facilities Management, Alyssa Youngquist, Interim Director of Surgery, Sadie Christiansen, Director of Human Resources, Christy Stevens, Director of Medical/Surgical. Richard said a 'fond farewell' to those that retired from Perham Health. New providers were named as well as the new services of Low dose lung scans, core breast biopsies, and dry needling. Perham Health will offer chemo-therapy in the future. Perham Living is a 5-star nursing home. Perham Health has had financial ups & downs. They received \$6,578,844 in COVID funds, they also had majored expenses due to COVID. They gave 10, 714 COVID vaccines in 2021. The hospital lowered the tax levy for the 2nd year.

Road Report: Presented by Stanley Marotz. Roads that were identified as needing work include; Fort Thunder, 450th Avenue, 460th and Harvest Avenue. The Township will have a Road Review meeting in April to review all roads.

Fire/EMS Report: Presented by Shawn Sweere. Kevin Keil attended the Annual Meeting. There

were 11 calls in 2020 and 15 calls in 2021. They received \$756, 00 in grant monies to replace engines and purchase other equipment. In May, they plan to purchase a new ambulance.

There was discussion on becoming a tax district. This process would take up to 2 ½ years.

Levy Discussion for 2022: Current levy that affects 2022 is \$285, 000. The Board recommended an increase to \$345,000 which will affect 2023. Discussion around the proposed Levy included that Perham Township has taken on two more additions, the possible increase in supplies, fuel, and service costs. There was also discussion around the roads in the township that need work.

450th and Harvest – Will look at in April. The County may help with costs due to increased traffic when Hwy 34 was closed.
