BUSINESS DISCUSSION:

Shawn Sweere attended the EMS Joint Powers meeting on 1/25 and gave an update. Meeting was held via Zoom. The current contract will renew on 2/21 with no changes. There was discussion on the Joint Powers Agreement, the pros and cons of implementing a tax levy. A new lift chair and equipment were purchased.

Kevin Keil attended the Annual Perham Fireman meeting on 1/26 and gave an update. Perham Fire and Rescue purchased the old St Johns school building for future planning purposes.

DJ attended ARPA webinar with updates to the grant program. ARPA funds can be taken as a revenue loss without needing the calculations. If funds are allocated as revenue loss, they can not be used for broadband, essential worker compensation, or grants to residents or businesses. ARPA funds can be used for road

improvements if they are allocated as revenue loss. ARPA funds can be used to pay debt or pensions. They can not be put into 'rainy day funds', or applied to any fund/payment not expendable with other Township funds.

Update on collaboration process with Otter Tail County on repairs to 450 St and 425th St due to heavier traffic during Hwy 34 closure. Perham Township has received one estimate to date on class 5 dirt. Discussion on areas of heavier road use. Perham Township will submit bids and costs to Otter Tail County in April when the Road Review meeting is held.
