Hospital Report: The hospital Annual report was shared to the Board by Richard Richter prior to the

meeting. It were reviewed to those present by Shawn Sweere.

**EMS Report:** The EMS Annual report was shared to the Board prior to the meeting. It was reviewed by Barb Felt. Barb attended the Annual EMS meeting and shared key points – the EMS's cash on hand is down 34%, lift assists are now being charged to patients, The EMS is down two paramedics, the Director of EMS has put in his resignation, Barb Felt is the new EMS Chairperson. There was discussion on the current billing process and the PSA laws.

**Fire Report:** The Fire Annual report was shared to the Board prior to the meeting. Barb Felt reviewed highlights to those present. There are 27 Service People on the Fire Department, in 2022 there were a total of 608 paid training hours, there were 1888 paid calls. Perham Township will pay \$35,348.00 to the Fire Department in 2023.

**Road Report**: Presented by Stanley Marotz, Supervisor. Roads the Board will focus on this year are 450<sup>th</sup> Ave south of Perham, Harvest Avenue, 450<sup>th</sup> St from the new addition to Cty 80. There was discussion on using traffic counters this road to see if the County will assist in rebuild. Blading was hard last summer due to dry weather. Perham Township rebuilt 460<sup>th</sup> Ave, re-paved Fort Thunder, saved money on snow removal by closing the center of MN Ave. There was discussion on using crushed concrete and/or crushed asphalt for future road tests.

**Discussion on creating an Annexation Agreement with the City of Perham.** There was discussion on implementing an Annexation Agreement with the City of Perham. The history of annexations was discussed and what options townships have. The Board will look into this further.

**Levy Discussion for 2023:** There was discussion on upcoming costs for the Township, increasing material costs, and building a better 'cushion' to be able to manage costs in the Township. Jon Stabler made a motion to raise the Levy from \$345,00 (2022) to \$431,000.
