Road Report: Status on Fort Thunder Rd blading. This has been completed.

Update on blading on Marion Lake Rd and Harvest Rd. Shoulders have been pulled in and cleaned up.

445th street, brush cleaned up. This has been taken care of.

Fort Thunder road by Oasis gravel on shoulders need to be filled, especially on turn to get on Fort Thunder. North Central will take care of this.

Fort Thunder: 2 4-way signs need replaced, and 2-4ways are missing. These are not required any longer and will not be replaced.

Z transportation needs blading before school starts. This has been taken care of.

Old County 8 that connects to County 8 on west side is missing stop sign and post all together. Part of the post is in the ground. This will be replaced.

Fort Thunder addition needs speed limit sign on the other entrance. It also needs to be bladed to get washboard out, but also to fill in some of the washouts and unevenness on the corners. Discussion as to whether there are enough residents on the road and what the speed limit could be. Per discussion with Civil Engineer, this is not required and the current speed limit is too slow and not enforceable.

Easy Lane: reviewed the estimate from North Central to add 3" of gravel to road. Motion was made to accept the estimate from North Central to add 3" of gravel to Easy Lane.

**Civil Engineer Report:** Jeff Stabnow presented a draft of possible re allignment and sureying of a few lots on Aerovilla Rd. that were impacted by the addition of a bus turn around. After discussion and review of aerial photos of driveways/properties being impacted it was decided to leave as is. Jeff Stabnow reviewed breakdown of cost estimates of Aerovilla Road to Supervisors. Work still needing to be completed consists of seeding and sealing – this will be done in the spring of 2022 due to how late in the season it is. Replacement of one mailbox will be completed yet this year. The Township has not yet paid for sealing, seeding, and the replacement mailbox.
